Eligibility Requirements

Each **company location** or **subsidiary** that installs EIFS during the time period **July 1, 2021-June 30, 2022** must have:

- At least one AWCI certified employee (CEM or CEP) at the management level;
- An AWCI certified foreman (CEM or CEP) for each project;
- At least forty percent (40%) or more of EIFS field employees (mechanics and crew supervisors) AWCI certified (CEM or CEP) and maintain that percentage for each project. **The 40 percent requirement includes all mechanics and supervisory personnel used on the project, whether they are full-time employees, subcontracted employees, subcontractors or independent contractors.**

Note: A company must have at least two AWCI certified employees to become an EIFSmart Contractor.

c) Additional Field Workers: The EIFS*Smart* Contractor seal requires that 40 percent of the EIFS field personnel (mechanics and crew supervisors) used by this company to work on each EIFS installation are certified by AWCI, whether they are full-time employees, subcontracted employees, subcontractors or independent contractors.

Since the need for and identity of additional field workers may change over the course of the year, it is not required that they be listed here. **The signature of the owner/officer in the affidavit in Section 4 of this application constitutes the company's understanding of and commitment to comply with this requirement.** As non-company personnel are used, the company can verify an individual's certification status by calling 703-538-1608 or by going to the online roster at www.awci.org/education/doing-it-right/eifs/certification-registry.

Code of Ethics for EIFSmart Contractors

Company shall maintain the eligibility requirements for each year the company holds the EIFSmart Contractor seal and will notify AWCI if the location is unable to maintain compliance for more than two months.

Company shall make it known to its employees that they are adopting industry accepted application means and methods as outlined in the AWCI EIFS—Doing It Right education program.

Company shall require application of the knowledge gained from the AWCI EIFS—Doing It Right education program among its EIFS supervisors and field force.

Company shall support employees as they abide by the Code of Conduct associated with their personal credential.

Company shall act in a professional manner and accurately represent the qualifications of an EIFSmart Contractor to its clients and the industry in general.

Company shall give accurate, unbiased responses when the service includes advice.

Company shall avoid any involvement, activity or influence that might conflict with the best interests of all parties.

Company shall stay informed of new guidelines, standards, codes and procedures for the application of EIFS.
