#### **Eligibility**

The company that produces the innovation must be a current AWCI member in good standing during the submission period and at the time of award presentation.

Only one submission per company allowed.

#### **Scoring**

Judges will evaluate the nominations based on the following:

- The innovation improves productivity in the wall and ceiling industry.
- The innovation enables wall and ceiling contractors to increase their scope of work.
- The innovation results in reduction of materials used.
- The innovation increases safety in the workplace.
- The innovation generates LEED points.
- The innovation decreases the cost of construction.
